

A Special Closed Meeting of the Albemarle County School Board was held on March 23, 2009 at 5:30 p.m. in Room 320 of the Albemarle County Office Building, 401 McIntire Road, Charlottesville, VA 22902.

Call to Order

At 5:42 p.m., Mr. Wheeler called the meeting to order.

Closed Meeting.

Mr. Price offered a **motion** to go into Closed Meeting as authorized by the Virginia Freedom of Information Act, section 2.2-3711(A) of the Code of Virginia under subsection 2 subsection 2 to discuss and consider the discipline of a high school student and the readmission of an expelled middle school student. Mrs. McKeel **seconded** the motion, **and the motion passed.**

Certify Closed Meeting.

At 7:55 p.m., Mr. Price offered a **motion** that the Board certify by recorded vote that to the best of each Board member's knowledge, only public business matters lawfully exempted from the open meeting requirements of the Virginia Freedom of Information Act and identified in the motion authorizing the Closed Meeting were heard, discussed or considered in the Closed Meeting. Mrs. Moynihan **seconded** the motion. **Roll was called, and the motion passed by the following recorded votes:**

AYES: Mr. Wheeler, Mrs. Moynihan, Mrs. McKeel, and Mr. Price.

NAYS: None.

ABSTAIN: Mr. Stokes, Mrs. Mouly and Mr. Koleszar.

Motion carried by a 4:0:3 vote.

Mr. Price offered a **motion** to suspend student number 1 for the remainder of the 2008 -09 school year and the first semester of the 2009-10 school year and to allow the student to participate in an alternative education program off ACPS sites. Mrs. Moynihan **seconded** the motion, **and the motion passed.**

Mr. Price offered a **motion** to allow student number 2 to continue receiving alternative education services through his IEP for the remainder of the 2008-09 school year, to deny the request for readmission into the school division for placement in the regular education setting for the 2009-10 school year but allow to him to receive alternative educational services through his IEP for the 2009-10, and to reapply for placement in the regular education program in the spring of 2010 for the 2010-2011 school year. Mrs. Moynihan **seconded** the motion, **and the motion passed.**
