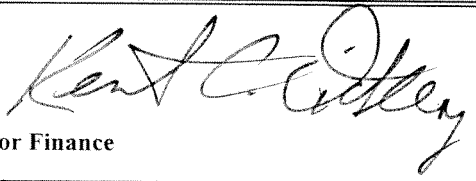
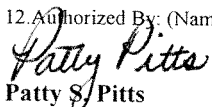

Special Instructions/Conditions: It is the intent of the General Assembly that the Department of Education provide bonuses from state funds to classroom teachers in Virginia's public schools who hold certification from the National Board of Professional Teaching Standards. Such bonuses shall be \$5,000 the first year of the certificate and \$2,500 annually thereafter for the life of the certificate. This appropriation includes an amount estimated at \$4,970,000 the first year and \$4,970,000 the second year from the general fund for the purpose of paying these bonuses. By September 30 of each year, school divisions shall notify the Department of Education of the number of classroom teachers under contract for that school year that hold such certification. ***See attached National Board Certification Incentive Award (NBCIA) Verification Report for your school division. The NBC Incentive Awards should be distributed by your school division based upon the following: those teachers/school counselors indicated on your NBCIA Verification Report as <u>initial</u> National Board Certified Teachers should receive <u>\$5,000</u> each; those teachers/school counselors indicated as <u>continuing</u> National Board Certified Teachers should receive <u>\$2,500</u> each.
