The County is currently working on a proposed zoning text amendment that addresses adding Landscape Contractors as a use permitted by Special Use Permit in the Rural Areas Zoning District and would like any feedback you may have on our proposed definition below.

This zoning text amendment proposes two changes: (1) adding "Landscape Contractor" as a use permitted by Special Use Permit to [Section 10](#) of the Zoning Ordinance and (2) defining "Landscape Contractor" in [Section 3](#) of the Zoning Ordinance.

Landscape contractor. "Landscape contractor" means an establishment providing landscaping services. For the purposes of this definition, "landscaping" means the modification of the landscape for an aesthetic or functional purpose.
