## Grants:

### New Business:

Greene County was notified on December 1, 2025, that it received \$12 million in grant funds through the **Virginia Department of Health**, per the General Assembly, toward the Raw Water Line and Pump Station and Intake, both projects necessary for the reservoir. The General Assembly put \$25 million aside for grants with Greene County and Bowling Green having priority. We also received \$3,000,000.00 in state funding in FY25 that carries over into FY26 for the reservoir that we can utilize once spend \$9 million on the project. I have reached out to the state regarding this amount and am awaiting reply.

As there was no full budget approved by the Federal Government but a continuing resolution for a couple months, I do not yet know the status of the more than \$1 million in Community Project Funding for the water main in Stanardsville. (We had requested \$5 million for the project). There is a 20% match for whatever amount is awarded. We won't know if we receive funding until the final Federal budget is approved. If they do not approve a full funding amendment, it will **not** be funded again.

We received word that we were approved for a project through the **Cybersecurity** grant program from the Commonwealth of Virginia. There is no match.

We did receive \$2,500.00 from the **Charlottesville Area Community Foundation and Bama Works** for the cages at the Animal Shelter.

We were awarded \$7,500.00 for the **Emergency Management Performance Grant** which will go toward the purchase of new mobile radio equipment. We have received word from the Federal government that some FEMA grants will not be moving forward that we have received funding through in the past, including the Emergency Management Performance Grant and the State Homeland Security Grant. We are unsure if others will be impacted.

### Upcoming grants:

**Department of Conservation and Recreation's** Resilience Plan application did open on 10/15/2025 and the due date is December 1, 2025. Staff has started working on that grant application.

**Old Business (still ongoing):**

I applied for the **Department of Conservation and Recreation's** grant to create a Resilience Plan.

**Virginia Department of Energy** Grant application is undergoing procurement at this time. We were awarded \$199,880.00 from the Virginia Department of Energy for workforce development program regarding energy audit certifications.

I have submitted a grant application to the **Virginia Department of Forestry for Stanardsville** Volunteer Fire Company for \$3,019.54. In the past we've heard in September. We still have not heard an answer of November 3, 2025.

We submitted an application to the **Rescue Squad Assistance Fund** for Lucas devices and a monitor defibrillator for EMS. We expect to hear on January 1, 2026.

Applied for the **Hazard Mitigation Planning Grant** for a generator at one of our pump stations. Greene County will cover 5% of the total cost of this grant. We were given approval of the pre-application and invited to submit a full application on March 31, 2025, however the deadline for this grant application period is not until July 2025, so I don't expect to hear anything for several months beyond that. I requested \$162,000.00.

We received award letters for both of the previous **Community Project Funding** requests and have begun work on the Byrne Justice Grant to purchase a Virtual Reality Training Simulator for the Sheriff's Office (\$70,000.00) that required no match. We have purchased the simulator and completed the reimbursement for this grant. We have begun the work for the Park under the HUD grant (\$750,000.00). We are moving forward with the site plan amendment that will be needed for the park upgrades. This full project will take two years due to scheduling around busy soccer seasons.

We continue to move forward on our **BRIC** grant for the Building and Planning and Zoning Departments. We have almost completed this.
