<b>SUBJECT:</b>	Allocation of Opioid Abatement Funds to Social Services
<b>DATE:</b>	February 3, 2026

### **Recommended action:**

**Approve the attached resolution to allocate \$16,294.00 from Opioid Abatement Direct Disbursement funding to the Department of Social Services for several projects.**

### **Background:**

Greene County has received \$206,116.95 in direct disbursements through participation in Opioid settlements since 2022. The Board has approved the use of \$155,614.00 for meeting the match requirements of the Rescue Squad Assistance Fund grants, leaving roughly \$50,502.95 with the fiscal year 2026 funding that has been disbursed. James Howard, with the Department of Social Services, has requested the use of \$16,294.00 for the following projects:

- Drug testing system improvements \$1,853.00
- Camera and microphone system for the conference room: \$3,128.00
- Chairs for the conference room: \$11,313.00 (26 chairs)

We believe Opioid funding could be utilized for these items due to the Jansen settlement requirement of: "Provide enhanced family support and childcare services for parents with Opioid Use Disorder and any co-occurring Substance Use

Disorder/Mental Health conditions.” The conference rooms will be where Family Partnership Meetings are held and sometimes that’s done via video conference—hence the need for new camera equipment as well. The improved drug testing equipment will help the department better monitor substance use in caregivers in the home that could put children at risk, as well as ensuring compliance with treatment services.

**RESOLUTION TO APPROPRIATE SIXTEEN THOUSAND TWO

WHEREAS, the funds in the amount of sixteen thousand two hundred ninety-four dollars (\$16,294.00) need to be appropriated from opioid settlement funds in the 2026-2027 budget of the County of Virginia.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of the County of Greene, Virginia that sixteen thousand two hundred ninety-four dollars (\$16,294.00) in opioid settlement funds be appropriated to the 2026-2027 budget of the County of Greene, Virginia.

BE IT FURTHER RESOLVED that the County Administrator of the County of Greene, Virginia is authorized to make the appropriate accounting adjustments in the budget to do all things necessary to give this resolution effect.
