Mayor Reed read the proclamation.

Electronic Participation

Chris Brown, city attorney, stated per the city's electronic attendance policy, Council Member Alsaadun will be attending this meeting virtually, and Council must approve.

5.c. Consider the special event application request for Harrisonburg Downtown Renaissance's Levitt AMP Harrisonburg Music Series on Wednesday evenings from July 2- September 2, 2026 (July 2 - Thursday date).

5.e. Public hearing regarding the real estate tax rate for Fiscal Year 2026-2027 to be set at \$1.01 per \$100 of assessed value

The FY 26-27 Real Estate Tax rate was approved on second reading.

6. Public Hearings

6.a. Consider a request from Kevin T. and Denise F. Goertzen for a special use permit at 1315 Carrera Lane

Adam Fletcher, director of community development, presented a request for Special Use Permit for a short term rental (STR) located at 1315 Carrera Lane. He reviewed the property, surrounding land use, the definition of STR's, difference between home stays and STR's, the definition of a dwelling space versus accessory dwelling space, and recommended conditions by staff.

He stated staff and Planning Commission (7-0) to approve the request as presented with conditions as amended.

At 7:25 p.m., Mayor Reed closed the regular session and called the first public hearing to order. A notice appeared in the Daily News-Record on Wednesday, May 27, 2026 and Wednesday, June 3, 2026.

Pat Kuszyk 57 E. Weaver, spoke on her concerns of parking and traffic on Carrera Street.

Kevin Goertzen, applicant, stated there will be no need for on street parking and noted this property was used as a home stay but wanted to be able to rent out for longer than home stays allow.

Panayotis "Poti" Giannakouros, spoke on the recent point in time presentation that mentioned STR's,

At 7:29 p.m., Mayor Reed closed the public hearing and the regular session reconvened.

6.b. Consider a request from Robin L. Lake to rezone 850 Canterbury Court

Adam Fletcher, director of Community Development, presented a request to rezone property located at 850 Canterbury Court, from R-1 to R-8C. He reviewed the property, the surrounding land use, submitted proffer, and the differences of the set-backs from R-1 versus R-8.

He stated staff and Planning Commission (7-0) recommended approval of the request.

Discussion took place regarding variances versus rezoning, setbacks, and appeals to the Board of Zoning Appeals process.

At 7:44 p.m., Mayor Reed closed the regular session and called the second public hearing to order. A notice appeared in the Daily News-Record on Wednesday, May 27, 2026 and Wednesday, June 3, 2026

Panayotis "Poti" Giannakouros, spoke on prime real estate and neighborhood communities that support each other.

Robin Lake, applicant, was available for any questions.

At 7:48 p.m., Mayor Reed closed the public hearing and the regular session reconvened.

A motion was made by Vice-Mayor Fleming, seconded by Council Member Dent, that this Rezoning be approved. The motion carried with a recorded roll call vote taken as follows:

6.c. Consider a request from Marilyn S. Pendlebury to rezone 1340 South Main Street

Agenda items 6c, 6d and 6e presented together.

Adam Fletcher, director of Community Development presented requests to amend proffers, and approve two special use permits (SUP's) for property located at 1340 S. Main Street. He reviewed the property, the surrounding land use, the zoning history of the property, submitted proffers, a conceptual layout, comparison of existing proffers and proffer amendments, the specifics of the special use permits, and suggested conditions for the SUP's.

He stated staff and Planning Commission (7-0) recommended approval of the request with suggested conditions attached to the SUPs as amended by staff.

Discussion took place regarding conditions, types of bedroom units, what determines the need for a Traffic Impact Analysis, and lack of direct community engagement from the developer.

At 8:14 p.m., Mayor Reed closed the regular session and called the third, fourth, and fifth public hearing to order. A notice appeared in the Daily News-Record on Wednesday, May 27, 2026 and Wednesday, June 3, 2026.

Mike Hendrickson, representative for applicant and contracted purchaser, reviewed the reasoning behind the proffers and changes to the original request.

The following spoke against the requests and asked to be tabled until safety measures could be addressed (vehicular traffic, safety for pedestrian traffic, congestion) and community engagement took place:

Heinz Harman, developer, stated city staff does a great job when reviewing proposed developments, all concerns are vetted, and Council can feel confident in their recommendations.

Panayotis "Poti" Giannakouros, spoke on the proposed development from the previous property owner, previous community issues,

At 8:49 p.m., Mayor Reed closed the public hearing and the regular session reconvened.

Discussion took place regarding the need for housing, types of bedroom units offered in this development, neighborhood concerns, JMU's proposed expansion, traffic in the area. Tom Hartman, director of Public Works, spoke on the recent neighborhood traffic calming study in which it was noted that Weaver Ave. and Crawford St. did not qualify to be considered in the next 3-year traffic calming program. He stated a road assessment can be done and possibly find alternative safety measures to implement.

A motion was made by Council Member Dent, seconded by Vice Mayor Fleming, to approve the rezoning request as presented. No vote

An amended motion was made by Council Member Robinson, seconded by Council Member Alsaadun, to table this item to allow for community engagement with the developer until the July 28, 2026 City Council meeting. The motion carried with a roll call vote as follows:

- 6.f.** Consider approving an ordinance amendment to Section 7-4-1(a)(1)(a), 7-4-1(a)(1)(b), 7-4-1(a)(2)(a), 7-4-1(a)(2)(b), 7-4-1(a)(3), 7-4-1(a)(4), 7-4-1(b)(1)(a), 7-4-1(b)(1)(b), 7-4-1(b)(2)(a), 7-4-1(b)(2)(b), 7-4-1(b)(3) of the Harrisonburg City Code increasing water, sewer/authority, and a seasonal tiered rate structure.

Chris Brown, city attorney, presented an ordinance amendment related to the water/sewer rate increase as presented in the FY 26/27 approved budget. He reviewed the amendments.

At 9:25 p.m., Mayor Reed closed the regular session and called the sixth public hearing to order. A notice appeared in the Daily News-Record on Monday, May 25, 2026 and Monday, June 1, 2026.

There being no one desiring to be heard, Mayor Reed closed the public hearing at 9:27 p.m., and the regular session reconvened.

Council Member Alsaadun stated he was not in favor of increasing the rates for city residents but in favor of an increase for Rockingham County residents. Mr. Brown stated the increase is for everyone and was included in the FY 26/27 Budget that was

approved. Mr. Banks stated these increases are part of a long term financial model and capital improvement plan to ensure that the water/sewer infrastructure is managed appropriately and replaced in a timely fashion to ensure all systems are up to the expectations of providing service to our residents.

Further discussion took place on how the tier-rate works, encouraging water conservation and other locality rates.

A motion was made by Council Member Robinson, seconded by Council Member Dent, that this ordinance amendment be approved. The motion carried with a recorded roll call vote taken as follows:

Keith Thomas presented an ordinance amendment related to the increase of the Stormwater Utility Fee. He reviewed the drainage improvement plan, and the following proposed projects:

Waterman Drive Corridor;
Charles Street to Madison Street;
Northeast- South section;
Northeast - North section;

Mr. Thomas reviewed the estimated project costs and amendments made to the ordinance.

Council Member Dent reminded everyone of the Stormwater Utility Fee Credit program.

Further discussion took place regarding the projects, funding, and rate structure.

At 9:43 p.m., Mayor Reed closed the regular session and called the seventh public hearing to order. A notice appeared in the Daily News-Record on Tuesday, May 26, 2026 and Tuesday, June 2, 2026

Panayotis "Poti" Giannakouros, spoke on the expense of the projects, engineered solutions versus natural solutions, and the stormwater utility credit.

At 9:46 p.m., Mayor Reed closed the public hearing and the regular session reconvened.

A motion was made by Vice-Mayor Fleming, seconded by Council Member Robinson, to approve the ordinance amendment as presented. The motion carried with a recorded roll call vote taken as follows:

Matthew Huston, city engineer, presented an ordinance amendment related to erosion control and stormwater management fees. He reviewed the background, options, details, examples of how fees will impact the city, how these fees match state fees, and the recommendations of staff.

At 10:01 p.m., Mayor Reed closed the regular session and called the eighth public hearing to order. A notice appeared in the Daily News-Record on Tuesday, May 26, 2026 and Monday, June 1, 2026.

There being no one desiring to be heard, Mayor Reed closed the public hearing at 10:01 p.m., and the regular session reconvened.
