SUBJECT: Amended School Operating FUnD (1111) and School Nutrition Fund (1114) budgets for FY27

City Council approval is being requested to amend the School Operating Fund (1111) and the School Nutrition Fund budget for Harrisonburg City Public Schools. The State of Virginia finalized their budget on June 29, 2026 resulting in updated state revenue. Additionally, we have updated federal revenue.

No new local tax dollars are required from the City Council to make this budget amendment. The Harrisonburg City Public School Board approved these amendments on July 7, 2026. The following tables will show the School Nutrition and Operating budget appropriations if these amendments are approved.
