The Virginia Department of Environmental Quality (Department) received a modification request for VWP Individual Permit No. 16-0730, issued on June 28, 2016. The modification request dated June 11, 2026, requested modification to update Part I- Special Condition D 12 and 13 to reflect the City of Harrisonburg's Drought Management Plan.

The Department has determined that the request qualifies for a minor modification in accordance with VWP Permit Program Regulation 9VAC25-210-380 B 2. In accordance with your request and pursuant to the VWP Permit Program Regulation 9VAC25-210 and § 401 of the Clean Water Act Amendments of 1977, Public Law 95-217, the Department approves your request to modify VWP Permit No. 16-0730.
