Special Use Permit – 387 Monticello Avenue (To allow short-term rental in R-1)

A request from Caitlin Denhigh for a special use permit per Section 10-3-34(7) of the Zoning Ordinance to allow a short-term rental in the R-1 Single-Family Residential District. The +/- 10,154-square-foot property is addressed as 387 Monticello Avenue and is identified as tax map parcel 26-Q-13.

Special Use Permit – 291 West Wolfe Street and 336 West Market Street (To allow recreational and leisure time activities in M-1)

A request from VG Harrisonburg Storage LLC for a special use permit per Section 10-3-97(10) of the Zoning Ordinance to allow for recreational and leisure time activities, which may include non-transient dwelling units in the M-1 General Industrial District. The +/- 5.35-acre property is addressed as 291 West Wolfe Street and 336 West Market Street and is identified as tax map parcel 35-R-23.

Zoning Ordinance Amendment – To create a new term and definition for “poultry hatchery” and to add poultry hatcheries as a by right use in M-1

Consider amending Section 10-3-24, Definitions, to add a new term and definition for “poultry hatchery” and to amend and Section 10-3-96(22), Uses permitted by right, to add poultry hatcheries as a by-right use in the M-1, General Industrial District.

Comprehensive Plan Amendment – To incorporate the Northeast Neighborhood Small Area Plan

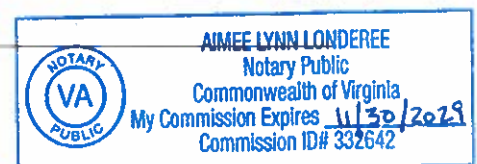
