Department Overview:








December 1, 2024-November 30, 2025 (Rolling Year)

Grants, Capital, and Other Updates:

Grants Updates:

- RSAF TJ-C05/12-24 (50/50 for Medications and Lockers): Medication lockers have been ordered and have an estimated delivery of mid-January.
- RSAF TJ-C03/06-25: Video Laryngoscopes and IV Pumps have been deployed to the field.
- SAFER EMW-2024-FF-01464: (SAFER EMW-2024-FF-01464: (Hiring) This grant has been accepted and we have an open recruitment for this staffing with an expected start-date of April 1, 2026.
- AFG EMW-2024-FG-01391: Equipment: This grant has been accepted. Some of the equipment has been ordered.

Capital Projects:

- 481050 Command Vehicle: Three Chevrolet Silverado 2500HD trucks have been delivered to the dealer. Upfitting work will begin in December.
- 481051 Ambulances: FEMS has selected a vendor and finalized a quote for a new ambulance that will be delivered around the end of this year. Lake Anna Rescue has started working with their chosen vendor for a custom spec ambulance.
- 482000 SCBA: Logistics staff worked with the vendor to negotiate competitive pricing. The SCBAs have been delivered and training is scheduled with the vendor.
- 482080 Boat: Construction is nearing completion, and inspection and delivery are expected in late December.
- 482091 Radio Tower: Site work is nearing completion, and Motorola continues work on radio equipment installation.
- 482180 Ladder Truck: An order has been placed for a new Rosenbauer ladder truck that is due at the end of 2027.

- 482180 Brush Trucks: Two new brush trucks (one for New Bridge and one for Locust Creek VFD) in February 2026. Refurbishment/body replacement of brush truck for Zion Crossroads is nearing completion.

Other Updates

- Graduation of the first annual F.I.R.E Citizens Academy.
- Safe Schools Taskforce meeting attended
- NAPS Law Enforcement and Interoperability Workshop held
- Kicked off OneDose Patient Care Protocol App
- Met with NVERS to prepare for upcoming EMS council changes

Staffing, Recruitment, and Career Development

- Current staffing levels: 83 of 86 positions filled.
- Career Development issued to members who hold certifications in Driver Pump Operator, Driver Aerial Operator, Acting Officers, and Education Coordinators along with completed release packets.
- 3 staff members in the precepting process to be released as Paramedics.

Training Division:

- Final weeks of the training academy (22 of 25-week academy)
- EMS Supervisors held several on shift CEU's to include rollouts of some new patient care guidelines and equipment.
- Culpepper CTEC Firefighter class used the training center on November 22nd for their burn.
- Louisa High School completed 14 of the 15 weeks of EMT program.
