**Public Hearing – Amendments to Louisa County Code Chapter 70; To Exempt Certain Property Owned by Fluvanna-Louisa Housing Foundation from Real Property Tax and Personal Property Tax**

The proposed amendments to Louisa County's Code will amend Chapter 70 Taxation by adding Section 70-232 to the Louisa County Code, titled "Fluvanna-Louisa Housing Foundation," which will exempt real property taxation and personal property taxation as described below.

Exempt from real property taxation is the below-described real property owned by Fluvanna-Louisa Housing Foundation, a non-profit organization:
