**NOTICE OF PUBLIC HEARING
LOUISA COUNTY BOARD OF SUPERVISORS**

The Louisa County Board of Supervisors will hold a public hearing on the following item(s) at 6:00 p.m., after regular business, on Monday, June 2, 2025, in the Public Meeting Room, Main Floor, Louisa County Office Building, 1 Woolfolk Ave., Louisa, Virginia:

**Public Hearing - Proposed Amendments to Chapter 86. Land Development Regulations;
Article II. Zoning Ordinance and Maps – (Retail Sale of Controlled Substances)**

Proposed amendments to Article I. General Provisions; Article II Zoning Ordinance and Maps. The draft amendment includes proposed new, modified and deleted definitions; and zoning strategies for regulating the retail sale of controlled substances, including hemp products intended for smoking, and other legally authorized substances; and establishes the zoning districts where the proposed uses may be permitted with a conditional use permit; and includes amendments to Sections 83-13; 86-109; 86-154; 86-171; 86-189; 86-204; 86-206; 86-222; 86-224; 86-240; 86-242; 86-259; 86-261; 86-277; 86-295; 86-296; 86-312; 86-339; 86-359; 86-378; 86-394; 86-410; 86-412; 86-429; 86-431; 86-447; 86-449; 86-465; 86-467; and 86-482. The purpose of the proposed amendment is to provide zoning and regulatory tools that balance public health and safety, economic opportunity, and community well-being while ensuring compliance with state and federal laws. The goal of these updates is to clarify the County's expectations for licensed medical providers versus retail operations involving controlled substances, while encouraging legitimate healthcare access in appropriate areas. THESE REGULATIONS APPLY THROUGHOUT ALL OF LOUISA COUNTY and are proposed pursuant to Va. Code §§ 15.2-2285 and 15.2-2286. The Planning Commission voted to forward a recommendation of approval on the proposed ordinance amendments.

**Public Hearing - Proposed Amendments to Chapter 86. Land Development Regulations;
Article I. General Provisions; Article II. Zoning Ordinance and Maps; Article III.
Subdivision; Article IV. Supplementary Regulations; and Article V. Signs.**

Proposed Amendments to Chapter 86. Land Development Regulations. These amendments are proposed to resolve any discrepancies that currently exist; update code sections based on amendments to the State Code of Virginia; amend sections to provide clarification, and consistent application of regulations; and remove regulations that are governed by more stringent State and Federal regulations. Article I. General Provisions include amendments to Division 2. Definitions. Section 86-13. Definitions; Division 4. Additional Requirements; Section 86-114. Short-term rental of a dwelling; Proposed amendments to Article II. Zoning Ordinance and Maps, Division 6. Zoning Districts and Land Uses; for yard regulations in Sections 86-142, 86-159, 86-344, 86-364; frontage, minimum lot width requirements in Sections 86-198, 86-381, and 86-397; Article III. Subdivisions, Division 3. Plat Requirements and Standards include proposed amendments Sections 86-567 Streets and alleys, and 86-614 Final plats. Article IV. Supplementary Regulations include amendments to Division 4. Shoreline Regulations, Sections 86-655 and in 86-656 related to dry hydrants and restroom facilities; and Division 5. Telecommunications Regulations, Sections 86-671 for mitigation and replacements. Amendments are proposed to Sections 86-683, 687, and 86-689 in Article V. Signs related to electronic message signs. THESE REGULATIONS APPLY THROUGHOUT ALL OF LOUISA

COUNTY; and are proposed pursuant to Va. Code §§ 15.2-2285 and 15.2-2286. The Planning Commission voted to forward a recommendation of approval on the proposed ordinance amendments.
