**RESOLUTION AUTHORIZING A SUPPLEMENTAL APPROPRIATION TO THE  
COMMUNITY DEVELOPMENT DEPARTMENT**

**WHEREAS**, the Ag/Forestal and Rural Conservation Committee presented recommendations to the Louisa County Board of Supervisors at its May 5, 2025 meeting on actions needed to conserve and protect critical agriculture and natural resources for the years to come; and

**WHEREAS**, one of the recommendations was for the County to hire a full-time staff member for the Community Development Department to administer agricultural and natural resource protection programs such as Ag and Forestal Districts (AFD), A zoning initiatives, Conditional Use Permits and new agriculture and natural resource protection programs; and

**WHEREAS**, the department is also in need of funding for a vehicle for the new position in an amount not to exceed \$40,000; and

**WHEREAS**, the department's workload has grown and so has the need for additional legal assistance to review documents which will require funding for professional services in the amount of \$50,000; and

**WHEREAS**, a budget supplement in the amount of \$190,363 will be needed to cover salary and benefit costs, vehicle purchase and professional service fees; and

**WHEREAS**, funding needed for the new position was not included in the FY2026 and needs to be appropriated at this time.

**NOW, THEREFORE BE IT RESOLVED**, on this 4th day of August 2025 that the Louisa County Board of Supervisors authorizes a budget supplement for a new position for the Community Development Department to administer agricultural and natural resource protection programs, the purchase of a new vehicle, and additional funding for professional services in the amount of \$190,363 as follows:

VRS (10081200-422100) - \$7,583  
457 Contribution (10081200-422200) - \$240  
Health Insurance (10081200-423100) - \$11,000

Professional Services (10081200-431200) - \$50,000
