In the FY2026 budget request cycle, the Louisa County Water Authority Board of Directors made a funding request in the amount of \$500,000 to make substantial repairs to the New Bridge Lagoon Wastewater Treatment Plant. The plant was evaluated as part of the Preliminary Engineering Report and these items were identified as necessary to bring the plant into more consistent compliance until the upgrade can be complete. All items except for one can be reused with the expanded facility. Staff will begin addressing the items specified in the PER as soon as the funds are received.

In the FY2026 budget request cycle, the Louisa County Water Authority Board of Directors made a funding request in the amount of \$200,000 for the Zion Crossroads Wastewater Treatment Plant - Supervisory Control and Data Acquisition (SCADA) System. The current SCADA system is antiquated, and parts are difficult, if not impossible, to acquire. This upgrade / replacement project is required by the regulatory agency to gather data and monitor trend data to meet permit requirements.
