2. The FY27 Budget Adoption is scheduled for April 27, 2026 and the FY27 Budget Appropriation is scheduled for May 4, 2026.
3. Finance will continue to monitor the state budget. Once finalized, adjustments will be made, as necessary, to the County's recommended budget.
4. Final FY2027 Health Insurance rates will be available in March. Any needed adjustments to the budget will be made at that time.
5. A fiscal year 2027 budget work session will be held in the Public Meeting Room on March 16, 2026 at 4:00pm.
