The following resolution was authorized:

A SUPPLEMENTAL APPROPRIATION REQUEST TO FUND ADDITIONAL STAFFING DUE TO INCREASED ENROLLMENT

WHEREAS, the Louisa County Public Schools enrollment has increased in the 2026-2027 school year; and

WHEREAS, the Louisa County School Board needs to use funds from the FY 2025-2026 carryover fund balance for the 2026-2027 school year for four teachers, two bus drivers, and two instructional assistants due to said continuing enrollment increase; and

WHEREAS, the funding needed for four teachers, two bus drivers, and two instructional assistants budgeted compensation (salary and fringe benefits) in 2026-2027 is \$496,000; and

WHEREAS, the Louisa County School Board is in need of a supplemental appropriation from the carryover fund balance in the amount of \$496,000 to cover these costs.

NOW, THEREFORE BE IT RESOLVED, that the Louisa County School Board respectfully requests the Board of Supervisors appropriate an additional amount of funding from the FY 2025-2026 carryover fund balance in the amount of \$496,000 to hire four teachers, two bus drivers, and two instructional assistants for Louisa County Public Schools to meet the needs associated with the increased enrollment for the 2026-2027 school year.
