SUPPLEMENTAL APPROPRIATION REQUEST FOR THE USE OF GENERAL ASSEMBLY FUNDS PROVIDED FOR THE BONUS AND OTHER LOCAL FUNDS

WHEREAS, the General Assembly provided funding for employee bonuses, and there are additional local matching carryover funds available in the combined amount of \$974,000 to support this distribution; and

WHEREAS, these funds require a supplemental appropriation and authorization for the disbursement of bonus funds to employees; and

WHEREAS, the School Board requests that the Board of Supervisors approve a supplemental appropriation to access these funds in the amount of \$974,000.

NOW, THEREFORE, BE IT RESOLVED, that the Louisa County School Board respectfully requests the Board of Supervisors to appropriate additional funding from carryover funds in the amount of \$974,000 for employees to provide a \$1000 bonus to all full-time and permanent part-time employees.
