Our mission at Dominion Energy is to deliver reliable, affordable and increasingly clean energy that powers our customers every day. To support these efforts, Dominion Energy is planning the Kraken Loop 500 kilovolt (kV) Electric Transmission Project.

The Project includes building a new approximately 70-mile 500 kV transmission line through Louisa, Spotsylvania, Caroline, Stafford, and Fauquier counties. The line will connect the existing North Anna Substation to the proposed Kraken Substation in Caroline County. The Kraken Loop will ultimately tie into the proposed Yeat Substation in Fauquier County. This investment strengthens the grid, supports Virginia's energy security, and ensures reliable power for your community.

Your input matters. Dominion Energy will meet with residents, local governments, and stakeholders to share plans and listen to feedback. You are invited to several opportunities to meet with the project team.
