Department Overview:








October 1, 2024-September 30, 2025 (Rolling Year)

Grants, Capital, and Other Updates:

Grants Updates:

- RSAF TJ-C05/12-24 (50/50 for Medications and Lockers): Medication lockers have been ordered.
- RSAF TJ-C03/06-25: Video Laryngoscopes for this grant have been delivered, and training will begin soon. IV pumps have also been ordered.
- SAFER EMW-2020-FF-01104 (Volunteer R&R): This grant is nearing closeout. We have funding for a few more sets of volunteer turnout gear for new volunteer firefighters.

New Grants:

- SAFER EMW-2024-FF-01464: (SAFER EMW-2024-FF-01464: (Hiring) We received notification that we have been awarded this funding!
- SAFER EMW-2024-FF-01614: (Volunteer R&R): Awards have started on this grant cycle, and, to-date, we have not received this award.
- AFG EMW-2024-FG-01391: Equipment: We received notification that we have been awarded this funding!

Capital Projects:

- 481050 Command Vehicle: Three Chevrolet Silverado 2500HD trucks have been ordered, and design work for the emergency upfitting packages is nearly complete.
- 481051 Ambulances: FEMS has selected a vendor and finalized a quote for a new ambulance that will be delivered around the end of this year. Lake Anna Rescue has started working with their chosen vendor for a custom spec ambulance.
- 482000 SCBA: Logistics staff worked with the vendor to negotiate competitive pricing. The SCBAs have been ordered, and are expected for delivery at the end of October

- 482080 Boat: Construction has begun, with completion, inspection, and delivery expected in mid-December.
- 482091 Radio Tower: Site work is nearing completion, and Motorola has begun its radio equipment installation.
- 482180 Ladder Truck: The Department's Fire Apparatus Committee has started meeting with vendors to discuss options, pricing, and delivery times for the County's next ladder truck.

Other Updates

- 9/11 Ceremony was held at Louisa Fire Station.
- Our first F.I.R.E Citizens Academy started.
- Held a short, intimate remembrance ceremony for Mia Ethridge.
- Spent the afternoon of 9/11 at the Lake Anna Food Lion for their first responder appreciation day with the Elementary students presenting Thank You cards
- Attended CAD-to-CAD demo in Spotsylvania

Staffing, Recruitment, and Career Development

- Current staffing levels: 86 of 86 positions filled.
- Career Development issued to members who hold certifications in Driver Pump Operator, Driver Aerial Operator, Acting Officers, and Education Coordinators along with completed release packets.
- 3 staff members in the precepting process to be released as Paramedics.

Training Division:

- In house Driver Aerial Operator (DAO) course scheduled to test October 9 & 10
- Recruit Academy completed their Firefighter 1 state certification test with 100% pass. HazMat Operations state certification testing with 100% pass. We are well above the state average for pass rates for this academy. Recruit Academy starts EMT October 14th and ends December 5th.
- October "PUSH" Training. 10/23, 10/24, 10/25. Will cover Hazmat.
- EMS Supervisors held several on shift CEU's
- Held our quarterly Officers' Summit class.
- Taught the TES administrators about Narcan.
